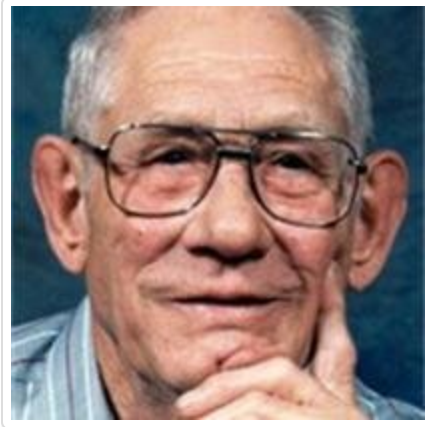




C.W. Greeson
